- 1. The Provincial Grand Master declared the meeting 'Open' at 3pm.
- **2.** The Provincial Grand Secretary read the letter of Dispensation permitting the meeting to be held virtually via the ZOOM platform.
- 3. The Provincial Grand Master acknowledged the members of the Ancient and Honourable Fraternity of Royal Ark Mariner who were in attendance.
- 4. Due to technical problems, the Chaplain was unable to conduct the Obituary for Brethren who had died during the preceding 12 months (Full list included below in the Provincial grand Secretary's Report).
- 5. The Provincial Grand Master welcomed the Assistant Grand Master, the Grand Secretary, our Past Provincial Rulers, all our Distinguished Guests, and the Heads of Other Order to the meeting.

#### 6. Minutes.

Congratulations are extended to all the above, with the wish that they have good health to enjoy their preferment, and the determination to continue to work hard for the betterment of the Order.

#### Membership (all figures are taken as at 31st December 2020)

The Membership at the end of 2016 was 1233. Last year (2019), it had fallen to 1136. This year we have lost a net total of 18 memberships. This decrease represents a further decrease of 1.58% over the last year; and a total decrease of 9.33% over the last 4 years. If we consider that over the 4 year period, 100 Brethren have passed to the "Grand Lodge Above", and we had 203 resignations, then clearly, 'resignations' is still a major issue. All resignations are followed up by contact from either the Deputy or the Assistant PGM, and it is imperative that details of all resignations are sent to Province as soon as Lodge Secretaries are informed of them – a follow-up phone call is useless several weeks later.

# THE PROVINCIAL GRAND MARK LODGE OF DURHAM TREASURER'S REPORT 2020

I am pleased to present and submit for adoption the Audited Accounts of the Provincial Grand Lodge of Mark Master Masons of Durham for the Year Ended 31st December 2020.

The Income and Expenditure Account shows a surplus for the year of £3,056.

As always, the principle items of income continue to be Lodge Dues and Fees of Honour. Expenditure continues to be monitored regularly.

As mentioned in previous Reports to you, increases in expenditure are planned over the next few years as we continue to replace or refurbish Provincial Grand Mark Lodge Regalia and furniture as required.

Brethren, once again we are indebted to the Provincial Grand Master and his Provincial Grand Officers who, in carrying out their duties continue to finance their attendance on official deputations to Lodges both within and beyond the Province during the year. The cost to Provincial Grand Mark Lodge, would be considerable if that were not the case, and we are grateful to those Brethren for their continued support and generosity.

So far as the Balance Sheet is concerned, the Accumulated Fund shows a balance of £31,194 at the 31st December 2020, with the Special Reserve Fund standing at £5,178. Brethren the 2020 Centenary Fund which was established in 2015 shows a balance of £14,847, following the £30,000 donation made to the Durham Mark Benevolent Fund. All surplus funds continue to be invested in an Investment Account with our Bankers.

I give 'Notice of Motion' that at the next Annual Meeting of Provincial Grand Lodge, I will propose that the level of Provincial Dues be reviewed.

In conclusion R W Provincial Grand Master and Brethren, I would like to record my thanks to the Lodges who continue to forward dues so promptly, the Provincial Grand Secretary, his Deputy, and Assistant, for their most valuable assistance and cooperation during the year.

#### INDEPENDENT AUDITORS' REPORT TO THE MEMBERS OF

#### PROVINCIAL GRAND LODGE OF MARK MASTER MASONS OF DURHAM

#### **Opinion**

We have audited the financial statements of Provincial Grand Lodge of Mark Master Masons of Durham for the year ended 31 December 2020 which comprise of income and expenditure account, balance sheet and the related notes. The financial reporting framework that has been applied in their preparation is applicable law and FRS 102 Section 1A, The Financial Reporting Standard applicable in the UK and the Republic of Ireland (United Kingdom Generally Accepted Accounting Practice).

In our opinion the financial statements:

- give a true and fair view of the state of the Lodge's affairs as at 31 December 2020 and of its income and expenditure for the year then ended;
- have been properly prepared in accordance with United Kingdom Generally Accepted Accounting Practice applicable to Smaller Entities.

#### **Basis for opinion**

We conducted our audit in accordance with International Standards on Auditing (UK) (ISAs (UK)) and applicable law. Our responsibilities under those standards are further described in the auditor's responsibilities for the audit of the financial statements section of our report. We are independent of the Lodge in accordance with the ethical requirements that are relevant to our audit of the financial statements in the UK, including the FRC's Ethical Standard, and we have fulfilled our other ethical responsibilities in accordance with these requirements. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

#### Conclusions relating to going concern

In auditing the financial statements, we have concluded that the trustees' use of the going concern basis of accounting in the preparation of the financial statements is appropriate.

Based on the work we have performed, we have not identified any material uncertainties relating to events or conditions that, individually or collectively, may cast significant doubt on the entity's ability to continue as a going concern for a period of at least twelve months from when the financial statements are authorised for issue.

Our responsibilities and the responsibilities of the trustees with respect to going concern are described in the relevant sections of this report.

#### Other information

Our responsibilities do not extend to any other information.

#### Matters on which we are required to report by exception

In the light of the knowledge and understanding of the Lodge and its environment obtained in the course of the audit, we have not identified material misstatements in the members' report.

We have nothing to report in respect of the following matters:

- adequate accounting records have not been kept, or returns adequate for our audit have not been received from branches not visited by us; or
- the financial statements are not in agreement with the accounting records and returns; or
- we have not received all the information and explanations we require for our audit; or

- the members were not entitled to prepare the financial statements in accordance with the small entities regime; or
- a satisfactory system of control over transactions has not been maintained.

#### Responsibilities of members

The members are responsible for the preparation of the financial statements and for being satisfied that they give a true and fair view, and for such internal control as the members determine is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, the members are responsible for assessing the Lodge's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless the members either intend to cease operations, or have no realistic alternative but to do so.

#### Auditor's responsibilities for the audit of the financial statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with ISAs (UK) will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these financial statements.

Irregularities, including fraud, are instances of non-compliance with laws and regulations. We design procedures in line with our responsibilities, outlined above, to detect material misstatements in respect of irregularities, including fraud. The extent to which our procedures are capable of detecting irregularities including fraud is detailed below:

#### Explanation as to what extent the audit was considered capable of detecting irregularities, including fraud

The objectives of our audit with regards to fraud are to design tailored and specific audit procedures to enable us to gather sufficient audit evidence. These tests are proportionate and appropriate to the Lodge in terms of assessed risk level and the nature of the entity's activities. However, the primary responsibility for the prevention and detection of fraud rests with those charged with governance.

- We obtained an understanding of the legal and regulatory requirements which applied to the Lodge, which we deemed to be the Lodge's Constitution and Bye-laws and the Statement of Recommended Practice: Accounting reporting by Charities and Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS102) (effective January 2015.)
- We obtained an understanding of how the Lodge had complied with these regulations by reviewing their treatment of transactions, reviewing minutes of meetings and discussing compliance with members.
- The risk of material misstatement of the financial statements due to fraud or error was assessed, and we deemed the entity to be low risk. The Lodge's Treasurer, who is deemed to have sufficient knowledge, works closely with the members who approve all transactions. We considered how fraud may occur within the financial statements and identified that the receipt of lodge dues and income from ties and tokens were susceptible to fraud or error. We designed our audit work to test the controls in place regarding the processing of these transactions and how these controls are capable of preventing or detecting fraud or error.
- Our audit procedures gathered evidence to support the claims of the members whilst maintaining professional scepticism to allow us to draw our own conclusion on the matter.

As part of an audit in accordance with ISAs (UK), we exercise professional judgment and maintain professional scepticism throughout the audit. We also:

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, design and perform audit procedures responsive to those risks, and obtain audit evidence that is sufficient and appropriate to provide a basis for our opinion. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the internal control.

- Evaluate the appropriateness of accounting policies used and the reasonableness of accounting estimates and related disclosures made by the members.
- Conclude on the appropriateness of the members' use of the going concern basis of accounting and, based on the audit evidence obtained, whether a material uncertainty exists related to events or conditions that may cast significant doubt on the Lodge's ability to continue as a going concern. If we conclude that a material uncertainty exists, we are required to draw attention in our auditor's report to the related disclosures in the financial statements or, if such disclosures are inadequate, to modify our opinion. Our conclusions are based on the audit evidence obtained up to the date of our auditor's report. However, future events or conditions may cause the company to cease to continue as a going concern.
- Evaluate the overall presentation, structure and content of the financial statements, including the disclosures, and whether the financial statements represent the underlying transactions and events in a manner that achieves fair presentation.

We communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that we identify during our audit.

#### Use of our report

This report is made solely to the members as a body, in accordance with the Lodge's constitution and by-laws. Our audit work has been undertaken so that we might state to the members those matters we are required to state to them in an auditors' report and for no other purpose. To the fullest extent permitted by law, we do not accept or assume responsibility to anyone other than the members and the members as a body, for our audit work, for this report, or for the opinions we have formed.

# OF MARK MASTER MASONS OF DURHAM BENEVOLENT FUND REPORT OF THE BENEVOLENT COMMITTEE FOR THE YEAR ENDED $31^{\rm ST}$ DECEMBER 2020

I am pleased to report that in spite of living with the financial and social implications of a pandemic, the Durham Mark Benevolent Fund has risen to the occasion and celebrated the centenary of our Mark Province in style. A magnificent donation of £30,000 from the Centenary Fund, under the chairmanship of V W Bro Frank Rankin, assisted the Benevolent Fund in donating £1,000 to each of the good causes nominated by our 64 Mark and Royal Ark Mariner Lodges. This project, inspired by the wish of the Provincial Grand Master to benefit young people, was completed early in the year in the hope that it could be celebrated at our Centenary Dinner but sadly this event has fallen victim to lockdown restrictions. However, a glance at the names of the beneficiaries, listed in the January 2021 Newsletter, together with the knowledge that £1,000 would make a real difference to each of them, should fill our members with pride in the fact that we have marked our centenary well.

Our other fundraising activity has been unavoidably depleted this year but a 4% return on our investments was reasonable in the circumstances. The income from Lodge donations suffered a dramatic fall but was saved by a £1,442 donation from Staindrop Lodge in the form of a final distribution of assets and we thank its former members for remembering the Benevolent Fund. We must also mention and thank the organisers of the Money Draw for their wonderful contribution of £2,700, the Durham Masonic Caravan and Camping Club for donating £200 and we cannot let the occasion pass without acknowledging a further £200 from the John and Marion Scott raffles. John's stated aim was always that his raffles should benefit the Benevolent Fund and his passing late in the year will be a great loss to the festive board fun at future Provincial Deputation visits.

Our main charitable giving this year has included the following:

Provincial Grand Lodge of Durham

- 2021 Craft Festival (8<sup>th</sup> of 9) £2,500

Centenary Grants £64,000

Heel and Toe £1,000

And many smaller grants to worthy causes including the distribution of PPE to local hospices sourced from a Mark Master Mason in Kent at no cost to our Fund.

The bulk of our investments are held in an Investment Trust designed especially for the charity sector and have provided income this year of £11,216 and an unrealised loss in market value of £48,236. Overall, our total funds have decreased in this eventful year by £82,446 to £318,218 at 31st December 2020.
